1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Copper Hills Dog Resort, Inc. ("Center").
2. I further understand and agree that in admitting my dog(s) to the Center, the staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or show aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that the Center and their staff and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation at the Center.
4. I further understand and agree that my dog will be co-mingling with other dogs during their stay at the Center. I understand and agree that dogs can sometimes receive minor cuts and scratches at daycare. I also understand and agree that there is an inherent risk of serious injury or disease when dogs owned by different people are allowed to co-mingle. If problems arise, I understand and agree to my dog(s) being treated as deemed best by staff and volunteers of the Center at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I certify that I have read and understand the policies of the Center as set forth on the preceding pages and that I have read and understand the conditions, and statements of this agreement, including the following:

FEES: Our rate for one to two nights is \$30/night per dog. Our rate for three nights or more is \$27/night per dog. Dogs must be pre-screened before being accepted. We offer a family discount of 40% off each additional dog's stay. Extended stay discounts are also available depending on the length of stay.

COPPER HILLS- DAYS AND HOURS: Pickups and drop offs at Copper Hills Dog Resort, Inc. can be arranged by appointment by calling our downtown location at 515-288-0957. Facility tours can also be scheduled by appointment.

If you are dropping off at Downtown Doggy Daycare in Des Moines, specific pick up and drop off times must be scheduled when you make the reservation. Hours for drop off are Monday through Friday from 6:30 am to 6:30 pm, Saturday from 8 am to 4 pm and Sunday from 12 pm to 6 pm. Hours for pickup are Monday through Friday from 2:30 pm to 6:30 pm, Saturday from 10 am to 4 pm and Sunday from 12 pm to 6 pm. Staff goes off duty at closing and there is a \$1.00 charge per 5 minutes for any pet left after closing. If pet is left one hour past closing, they will be considered a boarding client and you will be charged an additional fee.

RESERVATIONS: Required. Cancellations with less than 24 hours will be charged a \$20 fee.
