



“Teenager of the Year” Scholarship Contest Rules

In order to provide equal opportunities to all participating students, the following rules are provided and will be strictly observed.

1. This contest is only open to graduating High School Seniors who are citizens of the United States and residents of Texas.
2. Applications must be properly bound on the left side with hinges or staples in a standard “Mead” type folder or cover. Elaborate bindings are discouraged. Clear plastic or bulky covers are undesirable. The packet must not contain any loose documents. Counting the Official 4-Page application, the completed brochure must not exceed 15 pages.
3. An official high school transcript of student grades from the beginning of the ninth grade to the due date of the application may be a photocopy that bears the original seal or stamp and signature of the proper school authority. If the school provides the transcript in a sealed envelope, open the envelope and include the transcript as a page of the application packet.
4. Photocopies of the most recent set of SAT or ACT scores must be included.
5. Prizes provided by the Texas Elks State Association are as follows:

1 st Place Girl.....	\$1,500	1 st Place Boy.....	\$1,500
2 nd Place Girl.....	\$1,000	2 nd Place Boy.....	\$1,000
3 rd Place Girl.....	\$ 500	3 rd Place Boy.....	\$ 500
6. Each scholarship will be in the form of a Certificate of Award issued by the Texas Elks State Association conditioned upon the enrollment of the individual as a full-time student in an undergraduate four-year degree program at an accredited Junior College, College or University in the State of Texas within the calendar year the scholarship is awarded. These awards will be paid as scholarship funds directly to the school in which the student is enrolled. Separate “Verification of Student Enrollment” and “Special Instructions to University or College” forms will be provided to all winners for use in requesting funds.
7. The award may be used for tuition, books, student fees, laboratory fees (and room & board, if housed on campus). The scholarship will not cover expenses or payments for an academic year begun prior to July 1 of the year in which it is awarded.
8. TESA Youth Activities Committee will invite the 1st Place winners (one boy and one girl) and their parents or guardians to the Texas Elks State Association annual convention in Addison, Texas in June. Hotel rooms will be provided for one night for both the students and their parents/guardians.

All completed applications must be turned in to local Elks Lodges by March 1st.
